



**BP'S SUMMER CONCERT TICKET GIVEAWAY  
(the "Contest")**

**OFFICIAL RULES AND REGULATIONS**

The Contest is intended for viewing and participation in Canada only by legal residents of Canada (excluding Quebec) who have attained the age of majority in the province in which they reside, and shall be subject to and construed in accordance with the laws of Canada. **Please do not proceed if you do not satisfy these requirements at the time of entry. Entry into the Contest constitutes your acceptance to these Official Contest Rules and Regulations. NO PURCHASE NECESSARY.**

- 1) **ADMINISTRATION:** The Contest is administered and operated by Boston Pizza International Inc. (the "**Contest Operator**"). The decisions of the Contest Operator are final and binding in all matters as they relate to the Contest, including without limitation eligibility and/or disqualification of entries.
- 2) **ELIGIBILITY:** To be eligible to win a prize in the Contest, you must: (i) be a legal resident of Canada; (ii) have attained the age of majority in the province in which you reside on August 31, 2026; and (iii) not be an employee, contractor, agent or representative of (and not be a member of the immediate families of an employee, contractor, agent or representative of) the Contest Operator, Boston Pizza Canada Limited Partnership ("**BPCLP**"), Live Nation Canada (defined below), or any of their affiliates, agencies, prize suppliers, any franchisee of BPCLP or any of their respective shareholders, trustees, directors, officers, employees or agents with whom such employees contractors, agents and representatives are domiciled. For the purpose of the Contest, "immediate family" is defined as parent or any person residing in the same household or domiciled with any such employees, contractors, agents or representatives.
- 3) **CONTEST PERIOD:** The contest period for a chance to win a Prize (defined below) will commence on Friday, June 26, 2026 at 9:00AM (ET) and will conclude on Monday, August 31, 2026 at 11:59PM (ET) (the "**Contest Period**").
- 4) **PRIZES:** There will be five (5) prizes to be won, each consisting of two (2) general admission tickets to a Live Nation® produced and promoted concert of choice in Canada (a "**Concert**") being held between October 1, 2026 to December 31, 2027 (each, a "**Prize**"). The approximate retail value of each Prize varies between CA\$100 to CA\$1,000, depending on the chosen Concert.
  - (a) The Prize must be accepted as awarded and has no cash value, and will expire with no further effect unless exercised prior to December 31, 2027. **Winners (defined below) must select their preferred Concert and provide that selection at the time they submit the signed Declaration and Waiver (defined below) to the Contest Operator to claim their Prize.** Available Concert selections may be viewed at <https://www.livenation.ca/>. No prize substitution will be made except that the Contest Operator, in its sole discretion, reserves the right to substitute the Prize for a prize of equal or greater value.
  - (b) The Prize includes Concert tickets only and Winners are solely responsible for all additional costs, including but not limited to transportation, parking, accommodation, meals, taxes, and any other expenses associated with attendance. Tickets are redeemable until December 31, 2027, or while supplies last. All Concert selections are subject to availability, venue capacity, artist scheduling, and any applicable ticketing restrictions; no guarantee is made that the Winner's preferred Concert will be available and an alternative selection may be required. Blackout dates and other restrictions may apply. Not valid during sold out concerts, private parties or events not produced by Live Nation Canada, Inc. ("**Live Nation Canada**"). If a Winner is unable or unwilling to attend on the requested dates, the Prize will be forfeited and may be awarded to an alternate Winner. An unclaimed and/or unused Prize element will remain the property of Live Nation Canada. Selection of Concert seat locations is solely within Live Nation Canada's discretion. Ticket delivery method is at the sole discretion of Live Nation Canada, which may include transmission to a Winner by mail, email, mobile ticketing or placed at venue on a "Will Call" basis on the day of the Concert under the Winner's name. The Winner must be present to pick up tickets and a valid photo ID will be required if tickets are placed on a "Will Call" basis. Each Winner and their guest must be at the age of majority and must abide by all venue and event policies, including but not limited to, showing a valid photo ID at the Concert venue for age verification and/or identification purposes if requested. Live Nation Canada reserves the right to revoke full or partial Prize from

any Winner or Winner's guest who it and/or venue personnel deem may, in their sole discretion, be intoxicated, be a safety risk, have violated any venue policy or law, and/or may bring Live Nation Canada into disrepute. By entering the Contest, entrants acknowledge and agree that there are inherent risks involved in being in public spaces and that these risks may be present before, during and after any Concert, should they win a Prize. Resale or transfer of any prize element, including tickets, is prohibited. By entering the Contest, entrants agree to Live Nation Canada's [Terms of Use](#) and to abide by the health and safety measures in effect at the time of the Concert, should they win a Prize. Should any Concert be cancelled, the applicable Winner will be notified as soon as reasonably possible.

- 5) **HOW TO ENTER: NO PURCHASE NECESSARY.** During the Contest Period, scan the QR code provided on the dine-in menus at any Boston Pizza location (excluding Quebec) to access entry on the Contest website. On the website, follow the on-screen instructions to complete all fields on the entry form. One (1) entry will be made upon completing all fields and clicking submit.
- 6) **SELECTION OF PROSPECTIVE WINNER:** On Wednesday, September 9, 2026 at 11:00:00 AM (ET), a representative of the Contest Operator will randomly select five (5) entrants from all eligible entries received during the Contest Period to each win a Prize (each, a "**Winner**"). Each selected Winner will be contacted by the Contest Operator or a representative of the Contest Operator via telephone and/or email within three (3) days of the selection. If any potential Winner is unable to be contacted after two (2) attempts, he or she forfeits the Prize and another entrant may, at the sole discretion of the Contest Operator, be selected.
- 7) **ODDS:** The odds of winning a Prize are dependent upon the total number of eligible entries received during the Contest Period.
- 8) **AWARDING OF PRIZES:** The Contest Operator is not responsible for the failure, for any reason whatsoever, of a selected entrant to receive notification or for the Contest Operator to receive a selected entrant's response. No communication will be entered into by the Contest Operator with entrants except with the selected entrant. In order to be declared a Prize winner, the selected prospective Winner must:
  - (a) have entered the Contest in compliance with these Official Contest Rules and Regulations and be eligible to win a Prize pursuant to these Official Rules and Regulations;
  - (b) sign and return within a designated time period a declaration and waiver in a form prescribed by the Contest Operator (the "**Declaration and Waiver**"), confirming his or her acceptance and compliance with these Official Rules and Regulations and releasing the Contest Operator, Live Nation Canada, BPCLP, each of BPCLP's franchisees, Facebook®, TikTok®, Instagram® and X® and each of their respective employees, directors, officers, governors, shareholders, affiliates, representatives, parent companies, subsidiaries, professional advisors, and advertising and promotional agencies (collectively, the "**Released Parties**") from any and all liability arising out of, pursuant to, or as a result of the carrying out of the Contest, or any part of the Contest, including, without limitation, liability arising from the acceptance of and usage of the Prize as awarded, the administration of the Contest and the selection of the Winner pursuant to these Official Rules and Regulations, and his or her consent to the announcement of the Winner's name, and the use by the Contest Operator of the Winner's name, address, photograph or likeness, voice or statements for advertising and promotional purposes without any further compensation to the Winner; and
  - (c) correctly answer, without assistance from any person, machine or device, within a ten minute period, the skill testing question on the Declaration and Waiver.

**A Prize must be accepted as awarded. A Prize is non-transferable and non-redeemable for cash.** A Prize may not be substituted except by the Contest Operator, who reserves the right to substitute a Prize or any portion of the Prize with a prize of equal or greater value. By entering any part of the Contest, all entrants, should they win, agree to the use of their name, address (city only), photo, and/or image on video for publicity and promotional purposes without compensation. The Contest Operator reserves the right to disqualify any individual whom it finds in violation of these Official Rules and Regulations or tampering with the entry process. The Contest Operator reserves the right to refuse an entry from a person whose eligibility is in question or who has been disqualified or is otherwise ineligible to enter. **Any attempt by anyone to deliberately undermine the legitimate operation of the Contest or any part of the Contest is in violation of criminal and civil laws and the Contest Operator reserves the right to seek damages or other legal remedy to the fullest extent permitted by law.**

- 9) **LIMITATION OF LIABILITY:** The Released Parties are not responsible for errors in the offer or administration of the Contest, or any part of the Contest, including but not limited to, errors in the advertising, these Official Rules and Regulations, the selection and announcement of the winners or the distribution of any prize. In addition, the Released Parties shall not be liable any damages caused or alleged to be caused by: (a) any entry, prize or other correspondence or data that is lost, stolen, late, garbled, distorted, delayed, damaged or misdirected for any reason; (b) for any failure, interruption, technical malfunction or delay; (c) any e-mail, text message or other communication sent or received to or from the Contest Operator or any of its agents or designees, for any reason; (d) for any incorrect, untimely or inaccurate information, whether caused by users or by equipment or programming errors associated with or utilized in any part of the Contest; (e) for any technical or human error which may occur in the processing of any entry or entries in the Contest; (f) for problems with the function of any website or website feature (including, without limitation any features thereon), howsoever caused; (g) for the malfunction of, or damage caused to, any telephone network or lines, computer equipment, data, software, online systems, servers or access providers; (h) for any functionality lost due to not having cookies enabled; (i) for traffic congestion on the Internet; (j) for the security or privacy of information transmitted via telephone or computer networks; (k) for breaches of privacy due to interference by third party “hackers” or for any damage caused to or incurred by any entrant or any other person by reason of any such event or occurrence; or (l) for printing errors appearing in these Official Rules and Regulations or related Contest materials. The Contest Operator may terminate or withdraw the Contest without liability, at any time, at its sole discretion.
- 10) **FACEBOOK, TIKTOK, INSTAGRAM AND X:** Facebook, TikTok, Instagram and X: (i) have no way sponsored, endorsed or administered the Contest; (ii) are not associated or connected with any part of the Contest in any manner whatsoever; and (iii) are not liable in any way whatsoever in regard to any matter, which relates to the Contest. You understand that you are providing your information to the Contest Operator and not to Facebook, TikTok, Instagram or X. Any questions, comments or complaints will be directed to the Contest Operator and not to Facebook, TikTok, Instagram or X. Facebook, TikTok, Instagram and X are indemnified and held harmless from and against all damages, losses, and expenses of any kind (including reasonable legal fees and costs) for any claim related to the Contest including without limitation the publicity or administration thereof.
- 11) **SUBJECT TO APPLICABLE LAWS:** Each part of the Contest is subject to all applicable federal, provincial, municipal and local laws. The Contest Operator reserves the right to modify or terminate the Contest, or any portion thereof, at any time without notice to participants. The Contest is VOID WHERE PROHIBITED BY LAW.
- 12) **PRIVACY STATEMENT:** Personal information collected during the administration of the Contest, or any part of the Contest, will only be used in conjunction with executing the terms of the Contest as described in these Official Rules and Regulations. By entering any part of the Contest, the Contest Operator and its parent companies, subsidiaries, affiliates and agencies, may collect and use the information an entrant provides on the contest card, including Winner’s contact information, to qualify the Winner for the Contest and to contact the Winner and provide ongoing service regarding the same.
